INFORMATION NOTICE REGARDING THE PROCESSING OF PERSONAL DATA THROUGH SECURITY CAMERAS

This information notice has been prepared by Ulusoy Un Sanayi ve Ticaret A.Ş. (hereinafter referred to as "Ulusoy Un") to inform data subjects about the principles and procedures for the processing of personal data collected through closed circuit recording systems within Ulusoy Un, as required by the Law No. 6698 on the Protection of Personal Data ("the Law"), where Ulusoy Un Sanayi ve Ticaret Anonim Şirketi acts as the data controller. 1.Data Controller's Identity

The data controller is Ulusoy Un Sanayi ve Ticaret A.Ş., Denizevleri Mah. Alaçam Cad. Blok No: 42/1, Atakum – Samsun.

2. 2. Processed Personal Data and Purposes of Processing Personal Data

Your personal data are processed in accordance with the general principles specified in Article 4 of the Law. They are processed by the data controller or legal/natural persons appointed by the data controller, based on one or more of the conditions for processing personal data specified in Articles 5 and 6 of the Law, to achieve the following purposes: Şirketin yürütmüş olduğu tüm kişisel veri işleme faaliyetlerinde, In all personal data processing activities carried out by the Company, compliance with the obligations specified in the Law, all relevant legislation and Board decisions is ensured.

3. Transfer of Personal Data and Purposes of Transfer

Your personal data processed for the purposes described will be processed in accordance with the basic principles of the Personal Data Protection Law No. 6698 and the personal data processing conditions specified in Articles 5 and 6 of the Law. These data will be used only limited to the specified purposes and may be transferred to judicial authorities or relevant law enforcement agencies in order to resolve legal disputes, to hospitals and health service providers in order to fulfill occupational health and safety obligations, to our lawyers in order to follow legal processes, within the framework of confidentiality obligation, taking into account legal obligations and limitations, within the scope of the principles written in Article 8 of the Law.

Only a limited number of company employees can access the records recorded and maintained in digital media.

Live camera footage can be accessed by employees of the outsourced security company and employees of the department responsible for administrative affairs. However, the outsourced security company does not have access to these records.

4. Method and Legal Grounds for Collection of Personal Data


Your personal data is collected securely through cameras located in open and closed areas within the Company in order to fulfill the Company's legitimate interests and occupational health and safety legislation obligations and to achieve the above-mentioned purposes while conducting our business processes. In this context, your personal data are processed by automatic means without obtaining explicit consent in the light of the general principles stipulated in Article 4(2) of the Law or in the presence of the processing conditions listed in Article 5(2), and are destroyed at the end of the 30-day period. Personal data collected through security cameras are not transferred abroad in any way.

5. Rights of the Data Subject

Pursuant to Article 11 of Law No. 6698, your rights as a personal data owner are as follows:

- To learn whether your personal data is being processed or not,
- Request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred domestically or abroad,
- To request correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Although it has been processed in accordance with the provisions of Law No. 6698 and other relevant laws, to request the deletion or destruction of your personal data in the event that the reasons requiring its processing disappear and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- To object to the emergence of a result to the detriment of the person himself/herself by analyzing your processed data exclusively through automated systems,
- To demand the compensation of the damage in case of damage due to the processing of your personal data in violation of Law No. 6698.

For your requests regarding the use of your rights within the scope of Article 11 of the Law regulating the rights of the person concerned, you can send your written request together with the necessary information identifying your identity and your explanations regarding the right you want to use to "Denizevleri Mah. Alaçam Cad. Ulusoy Un Sanayi ve Ticaret A.Ş. Blok No: 42/1 Atakum - Samsun" with wet signature or via registered e-mail via ulusoyunsanayi@hs01.kep.tr or via kvkk@ulusoyun.com.tr by using your e-mail address, stating that the subject is "Personal Data Protection Law Information Request". You can access the application form physically from our company headquarters or via the website with the extension www.ulusoyun.com.tr.



The applications must include name, surname and wet signature if the application is in writing, Turkish ID number for citizens of the Republic of Turkey, nationality, passport number/ID number for foreigners, residential or workplace address for notification, e-mail address for notification, telephone or fax number and the subject of the request.

In the application you will make to exercise your rights specified in the Law as a personal data owner and containing your explanations regarding the right you request to exercise; the matter you request must be clear and understandable, the subject of your request must be related to your person or if you are acting on behalf of someone else, you must be specifically authorized in this regard and document your authority, the application must contain identity and address information and documents certifying your identity must be attached to the application.

The applications you make within this scope will be finalized as soon as possible and within 30 days at the latest. If the relevant person's application is to be answered in writing, no fee is charged for up to ten pages. A transaction fee of 1 TL may be charged for each page over ten pages. If the response to the application is given in a recording medium such as CD, flash memory, the fee that may be requested by Ulusoy Un may not exceed the cost of the recording medium.
