1. 1 Identity of the Data Supervisor

2. Your Personal Data Processed and Purposes of Processing Personal Data

Personal Data Collected within the Scope of Card Access System and Wifi Access Data:

Identity	Name, Surname, Year of Birth, TR Identity Number (Physical Visitors and Wifi Access Providers)
Communication	Phone Number (Wi-fi Access Providers)
transaction security	IP Number, MAC Address, Sites visited (Wifi Access Providers)
physical space security	Security camera surveillance records (Only video is recorded without audio recording.) (Physical Visitors)



Your personal data processed by our Company; In accordance with the responsibilities imposed by the Law No. 5651 on the Regulation of Publications on the Internet and Combating Crimes Committed through These Publications and other relevant legislation, by adhering to the basic principles of KVKK, We process for the purposes of;

- Ensuring the security of all technical facilities and premises of our company,
- Fulfillment of our regulatory obligations,
- Execution of emergency management processes,
- Execution of information security processes,
- Execution of access authorizations,
- Execution of activities in accordance with the legislation,
- Ensuring physical space security,
- Conducting occupational health / safety activities,
- Execution of risk management processes,
- Ensuring the security of data controller operations,
- Creation and follow-up of visitor records,
- In addition, regulatory and supervisory institutions and legal regulations
- as required or mandated by law, as set forth in the law
- determined to ensure the fulfillment of obligations
- requirements and obligations,
- Provided that the interest does not prejudice the fundamental rights and freedoms of the person concerned
- Protection of the legitimate interests of the company,
- Existing or future legal disputes
- Resolution,
- With public institutions and organizations within the scope of our legal obligation
- Requests from official institutions and authorized institutions
- Answer,
- Detection of unlawful entries and notification to the relevant persons/ institutions,

3. Transfer of Personal Data and Purposes of Transfer

Your personal data processed within the scope of the purposes described; In accordance with the basic principles stipulated by the Personal Data Protection Law No. 6698 and the personal data processing conditions and purposes specified in Articles 5 and 6 of the Law, by the Company; limited to the above-mentioned purposes; In order to resolve legal disputes or to resolve legal disputes or to the judicial authorities or relevant law enforcement agencies if requested by the relevant legislation and to follow up the legal processes, it may be transferred to our lawyers and our lawyers within the framework of the confidentiality obligation within the scope of the principles written in Article 8 of the Law within the framework of legal obligations and legal limitations.

Your processed personal data is not shared with abroad.

4. Method and Legal Grounds for Collection of Personal Data

Your personal data is collected by our Company verbally, in writing and/or electronically, through electronic channels when you connect to the free wifi network, your image records are collected through security cameras, your identity is collected by taking your identity in accordance with all security measures during the delivery of the card in order to use the card access system during your entry to the company, and your identity is returned during the return of the card, within the framework of the legitimate interest of the data controller and the legal obligation of the data controller. In this context, your personal data are processed by automatic means without obtaining explicit consent in the light of the general principles stipulated in Article 4(2) of the Law or in the presence of the processing conditions listed in Article 5(2).


5. Rights of the Data Subject

Pursuant to Article 11 of Law No. 6698, your rights as a personal data owner are as follows:



- Learn whether your personal data is being processed,
- Request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred domestically or abroad,
- To request correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- Although it has been processed in accordance with the provisions of Law No. 6698 and other relevant laws, to request the deletion or destruction of your personal data in the event that the reasons requiring its processing disappear and to request notification of the transaction made within this scope to third parties to whom personal data is transferred,
- To object to the emergence of a result to the detriment of the person himself/herself by analyzing your processed data exclusively through automated systems, In case of damage due to the processing of your personal data in violation of Law
- No. 6698, to request the compensation of the damage. In applications, name, surname and wet signature if the application is in writing, TR ID number for citizens of the Republic of Turkey,

For your requests regarding the use of your rights within the scope of Article 11 of the Law regulating the rights of the person concerned, you can send your written request together with the necessary information identifying your identity and your explanations regarding the right you want to use to "Denizevleri Mah. Applications must include name, surname and wet signature if the application is in writing, Turkish ID number for citizens of the Republic of Turkey, nationality, passport number/ID number for foreigners, residential or workplace address for notification, e-mail address for notification, telephone or fax number and the subject of the request.

As a personal data owner, in the application you will make to exercise your rights specified in the Law and containing your explanations regarding the right you request to exercise; the matter you request must be clear and understandable, the subject you request must be related to your person or if you are acting on behalf of someone else, you must be specifically authorized in this regard and document your authority, the application must contain identity and address information and documents certifying your identity must be attached to the application.

Your applications within this scope will be finalized as soon as possible and within 30 days at the latest. If the relevant person's application is to be answered in writing, no fee is charged for up to ten pages. A transaction fee of 1 TL may be charged for each page over ten pages. If the response to the application is given in a recording medium such as CD, flash memory, the fee that may be requested by Ulusoy Un cannot exceed the cost of the recording medium.
